- c. crude oil (including crude mineral oil, asphalt, ozokerite, hydrocarbon, and bitumen found in a natural state in solid, viscous or liquid form, including liquefied natural gas);
- d. by-products (including helium, carbon dioxide, sulfur and others made from petroleum production);
- e. hydrocarbon compounds found in a natural and independent state in solid, viscous, liquid or gaseous form;
- f. heavy hydrocarbon directly coming from their fields or from gas separation by physiochemical process, including ethane, liquefied petroleum gas (cooking gas or LPG), propane and butane;
- g. coal, oil shale or other rocks from which petroleum can be refined, extracted and transformed by physiochemical process, including all kinds of petroleum oil; and

3.
